**Analysis**: The proposed FY 2025-2025 Budget is balanced utilizing the proposed and current millage rate of 9.9759. The revenue derived from the ad valorem property tax is essential for funding municipal operations. The proposed and current millage rate of 9.9759 mils represents a 2.14% increase over the calculated rolled-back rate of 9.7665.
