This ordinance revises the schedule of fees and charges for water service charged by the Village. Per the ordinance's recitals the Village Commission of the Village of Highland Park has determined that it is in the best interests of the health, safety, and welfare of the public to amend Ordinance 2008-06 by providing for a rate increase for water services to meet the costs of public water system maintenance and repair.
